RULES & REGULATION FOR HALL BOOKING:

1. Payments of Hall Rent, Security Deposit and Catering Advance shall be made in advance at the time of booking in favor of NMSA.
2. Prior to confirmation, please check the details of the booking like Date of Booking, Hall required, Advance Amount paid etc.
3. **The area surrounding Club House has been declared as "Silence Zone" by Municipal Corporation. Accordingly, playing of live orchestra / band / banjo / firecrackers, within or outside Club House Premises, is not permitted. In case of violation of this rule, member and members' guest shall be solely responsible for police action and an amount of Rs.25,000/- shall be levied as Penalty, which shall be deducted from Security Deposit.**
4. Consumption of Food/Liquor/Pan/Gutka is not permissible in the S.J. Hall.
5. All area of the Club House Premise, being public place, is "No Smoking Zone".
6. Members are requested to take care of their own belongings; NMSA is not responsible for any loss of valuables or theft.
7. Sticking of bills or banners on the walls is not permitted. If found guilty, an amount of Rs.5,000/- will be penalised, which shall be deducted from the Security Deposit.
8. Any damage to the Club property, during the function, will have to be borne by the member and the same will be recovered along with the final bill.
9. Preponment and postponement charges for hall booking
For conference hall and Dining hall-Rs.1,000/-+GST
For Mini Hall-Rs.500/-+GST
S.J.Hall for 6 hrs-Rs.2,000/-+GST
S.J.Hall for 12 hrs-Rs.3000/-+GST
10. For any Hall booking, cancellation has to be done in writing only.
11. NMSA has official Caterer & Decorator for the functions held within the premises. Members are requested to co-ordinate with them.
12. Outside food is not permitted in the club premises.
13. **Playing of any music after 10:00 p.m. onwards is not permitted. Member and Members guest are liable for Police action if any music is continued beyond 10.00pm and Rs-15000/-Administration charges will be recovered.**
14. **Loud Music is not allowed in Mini Hall (like DJ and Sangeet etc.)**
15. Playing of any music inside the hall requires a "Public Performance License". For any legal action against member and members guest by Authorities, NMSA shall not be responsible.
16. Serving of liquor inside the hall shall be permitted only after obtaining necessary license from Excise Department Thane.
17. No refund / discount are admissible in unlikely event due to unexpected Natural Calamity like heavy rains etc or events beyond NMSA's control like Eelectricity Failure from MSEB.
18. Refunds, if any, after the final settlement will be made by cheque only. Refund will be made in favour of member only.
19. For any legal action due to breakage of rules mentioned above the member shall be responsible for the same.
20. The Managing Committee of NMSA reserves the right to alter any condition / clauses at any time.
21. The hall shall be subject to inspection at any time by any authorized representative of the N.M.S.A
22. **No time extension for hall shall be granted after 11.00 pm**
23. **No rituals like home, hawan, night fere are allowed inside the hall**
